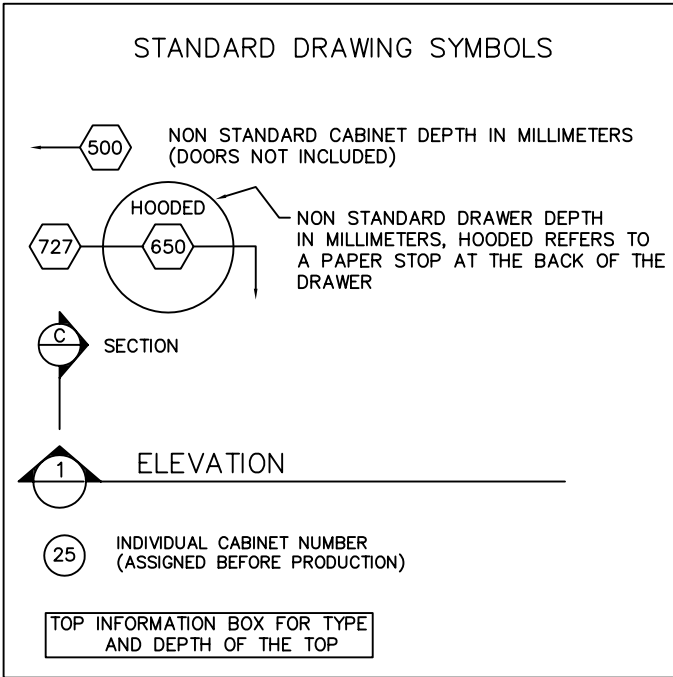

GENERAL NOTES

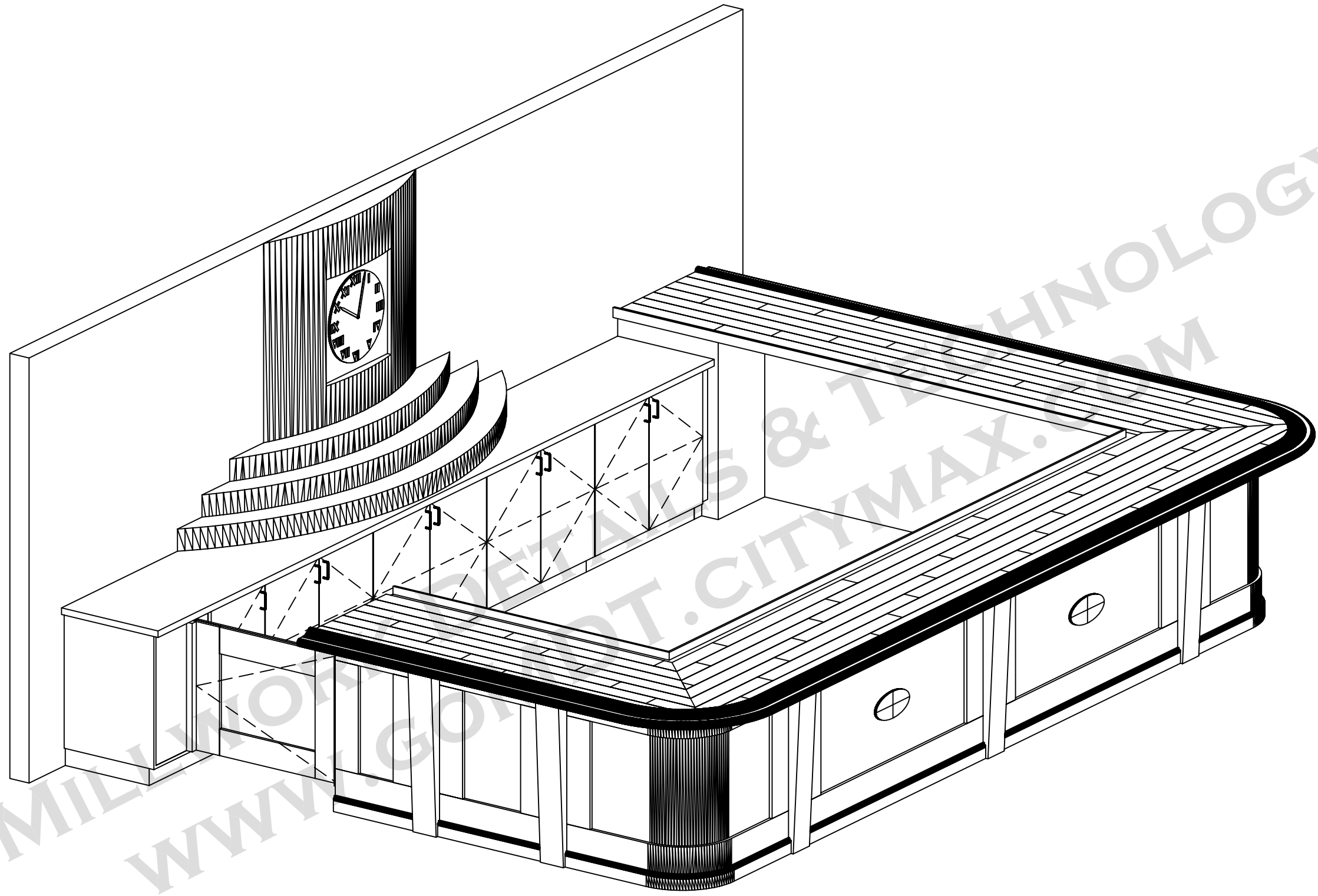
1. ALL OVERALL DIMENSIONS SHOWN ON THESE DRAWINGS ARE APPROXIMATE AND ARE SUBJECT TO ACTUAL FIELD DIMENSIONS.
2. ALL BASE AND TALL CABINETS SHALL BE 23¼" (590mm) DEEP (DOOR AND DRAWER FRONTS ADDITIONAL) UNLESS NOTED OTHERWISE.
3. ALL WALL CABINETS SHALL BE 12" (305mm) DEEP (DOORS ADDITIONAL) UNLESS NOTED OTHERWISE.
4. ALL CABINETS AND COUNTERTOPS WILL BE CONSTRUCTED OF INDUSTRIAL GRADE (45-47 LB.) PARTICLE BOARD UNLESS NOTED OTHERWISE.
 - A. CABINET SIDES, UNFINISHED ENDS, AND WHEN REQUIRED, CABINET TOPS TO BE ¾" PARTICLE BOARD WITH WHITE MELAMINE ON CABINET INTERIOR SURFACES. BASE AND TALL CABINET BOTTOMS TO BE ¾" PARTICLE BOARD LAMINATED WITH WHITE MELAMINE ON CABINET INTERIOR SURFACE. WALL CABINET BOTTOMS TO BE ¾" PARTICLE BOARD LAMINATED ON THE INTERIOR WITH WHITE MELAMINE, AND THE EXTERIOR WITH PLASTIC LAMINATE.
 - B. CABINET BACKS TO BE ¾" PARTICLE BOARD LAMINATED WITH WHITE MELAMINE.
 - C. CABINET SHELVES WILL BE ¾" THICK LAMINATED WITH WHITE MELAMINE ON BOTH SIDES. ALL SHELVES WILL HAVE WHITE 1MM PVC ON THE EXPOSED EDGE, UNLESS NOTED OTHERWISE.
 - D. ALL DOOR FRONTS, DRAWER FRONTS, AND FINISHED ENDS WILL BE ¾" PARTICLE BOARD WITH VERTICAL GRADE PLASTIC LAMINATE ON THE FACE AND WHITE MELAMINE ON THE BACK SIDE UNLESS NOTED OTHERWISE.
5. ALL CABINET EDGES WILL HAVE MATCHING VENEER UNLESS NOTED OTHERWISE.
6. ALL DOOR AND DRAWER FRONT EDGES WILL HAVE MATCHING VENEER UNLESS NOTED OTHERWISE.
7. DRAWER BOXES WILL BE HARDWOOD DOVETAIL DRAWERS U.N.O.
8. DRAWER SLIDES SHALL BE ACCURIDE FULL EXTENSION U.N.O.
9. CABINET HINGES TO BE BLUM CONCEALED SELF-CLOSING 125° OPENING.
10. PULLS TO BE SUPPLIED BY OWNER ON THIS PROJECT UNLESS NOTED OTHERWISE.
11. ALL SHELVES ARE ADJUSTABLE (UNLESS NOTED FIXED ON DRAWINGS) ON CLEAR BLUM SHELF CLIPS. THE HOLES ARE DRILLED 32mm O.C.
12. ALL CASEWORK MANUFACTURED BY YOUR MILLWORK COMPANY, INC. IS MANUFACTURED USING THE IMPERIAL SYSTEM OF MEASUREMENT. ALL METRIC MEASUREMENTS SHOWN IN PARENTHESIS ARE NOMINAL.
